

BEST GST INCENTIVE: RECOVERY OF UP TO 200% of FCI

- Tax Reimbursement (Net GST) on pan India sales (not limited to sales within the State)
- Net GST includes SGST, CGST and IGST
- Recovery up to **15 years**
- Fixed Capital Investment (FCI) includes **cost of land**
- Minimum Annual Incentive Assurance Policy allows recovery of 2.5% of FCI even if there is inverted tax structure

















ENGINEERING IN OUR DNA



- Accounts for **92%** of India's total production of bicycle parts & 75% of bicycle production
- Home to **largest bicycle** manufacturer



Home to Precision Engineering



- No. 1 in country in machine & hand tools production
- Production of Hi-Tech engineering products: Special Alloy Steel with 1 PPM, 4K Linear Imager, Microvalve for Electric Propulsion Systems etc.



- North India accounts 52% of total India's tractor production out of which Punjab's contribution is 41%
- Punjab serves **2/3rd** of total OEMs in farm equipment segment

- SCL developed two kinds of **Low Drop Out Regulators** for use in fabrication of equipment on-board spacecraft rocket Chandrayaan - 2
- SCL supplied > 100,000 units of Multiplexed Analog Signal Processor (MANAS) ASIC for use in high energy physics experiments (ALICE) at Large Hadron Collider (**CERN- Geneva**)

State Govt. is facilitating MSMEs across sectors for reduction in cost of doing business and increase in efficiency of production

(i) Reducing Cost of Business

- Numerous attractive incentives for MSMEs are available under Punjab Industrial & Business Development Policy 2017.
- Govt. is working with **financial** institutions to facilitate easy access to finance
- For development of **Common Facility Centre** (CFC) (assistance of up to INR 15 crore), 23 clusters identified by GoP under the MSE-CDP Programme of GoI. Currently, 4 **CFCs** are under various stages of **implementation** in Punjab.

(ii) Ease of Doing Business

- Invest Punjab model has been extended to **district level** for MSMEs
- Make in Punjab Policy: Goods manufactured in Punjab are preferred in **Govt**. **Procurement**
- MSE Facilitation Councils: Support for **Resolution of Payment** issues with Pan India Buyers. Constituted in 7 districts. 105 claims Worth INR 233 crore disposed off (since Nov 2018)
